Payment in full is required before any action from our side.

All orders must be prepaid.

All prices are deemed without VAT. 17% VAT should be added if invoiced to Cyprus companies.

Annual services are billed for 12 months intervals, in advance. Subsequent bills are issued 30 days prior to the expiry of the purchased service. Annual services purchased during calendar year, shall be billed pro rata temporis to include a full year.

Bank opening is subject to bank approval of the client. If a client is refused bank account opening in Cyprus we will refund the corresponding amount.

CYPRUS TAXATION BRIEF

Cyprus profit tax – 10%;

Dividends paid to non residents - 0%

Double tax treaties – Austria, Belarus, Belgium, Bulgaria, **Canada**, **China**, Czech Republic, Slovakia, Denmark, Egypt, France, Germany, Hungary, India, Ireland, Italy, Kuwait, Lebanon, Malta, **Mauritius**, Moldava, Norway, Poland, Quatar, Romania, **Russia**, San Marino, **Seychelles, Singapore**, South Africa, Sweden, **Swiss Confederation**, Syria, Thailand, **United Kingdom** of Great Britain and Northern Ireland, **United States** of America, Yugoslavia (Croatia. FYROM, Montenegro), CIS States (Ukraine, Kazahstan, Kirgistan, Tadjikistan, Turkmenistan, Uzbekistan).

CYPRUS CORPORATE BRIEF

A minimum of one director is required.

Although it is not mandatory to have local directors, this is highly advisable especially where the provisions of a double tax treaty are going to be utilized; and it is important to show that the company is effectively managed and controlled from Cyprus (tax resident in Cyprus) and that all or the most important company decisions are taken in Cyprus.

Also, for practical reasons, it is recommended that the Secretary is a Cyprus resident. Directors can also act as Secretaries, but a sole Director cannot act as a Company Secretary, except only in the case of a "one shareholder - one director - one secretary company" when one person can indeed act in all three aforementioned capacities.

Shares cannot be issued to the bearer.
